#### Revision of the Section 4, Chapter XIV of the Establishments Code Combined Allowance.

The 182<sup>nd</sup> Governing Council meeting held on 29/03/2019 has been decided to adopt revision of the E-code combined allowance as follows:

"Any officer travelling outside from the office under the directions of myself can be reimbursed the cost of living, subjected to maximum of Rs.2000/- per day and in such a case he/she is not eligible for combined allowance."

Accordingly, I hereby revoke all previous circulars which have been issued earlier on this subject. This circular will be effective from 02.05.2019.

# Revision of the Section 4, Chapter XIV of the Establishments Code Combined Allowance

our attention is drawn to sub sections 4:4:3 and 4:5, Chapter XIV of the Establishments Code.

The Cabinet of Ministers has decided at its meeting held on 24.07.2018 to revise the said b sections in the following manner.

- 4:4:3 When an officer spends more than 24 hours he could be paid an additional 50% of the Combined Allowance for each period of 24 hours up to a maximum period of three weeks. The additional 50% of the Combined Allowance is not payable for any period less than 24 hours.
- 4:5 Rate The rate of Combined Allowance payable will be based on the officer's monthly salary as follows. (See sub section 1:3)

## Monthly basic salary

# Combined Allowance for each complete period of 24 hours

Up to Rs.32,779.00	Rs.700.00
From Rs.32,780.00 up to Rs.43,479.00	Rs.800.00
Rs.43,480.00 and above	Rs.1,000.00

Above provisions shall be effective for travelling on duty on or after 23.08.2018.
