Post-qualification Requirements-Multimedia

Requirements not included in the text below shall not be used in the evaluation of the Bidder's qualifications.

- (a) **Financial Capability:** The Bidder shall furnish documentary evidence that it meets the following financial requirement(s):
- Bidder must be able to prove that it has sound financial capacity to perform the contract without any disturbance, by its Audited Financial Statements of last 3 years.
- (b) **Experience and Technical Capacity** The Bidder shall furnish documentary evidence to demonstrate that it meets the following experience requirement(s):
- Experience in supplying more than 25 Nos of Multimedia Projectors for any reputed Institution (in single order) within last 3 years and selling more than 50 Multimedia Projectors per annum,
 - At least 5 years being in the market by supplying IT equipment such as Multimedia Projectors etc,
 - Bidder should be able to provide services to island wide, Bidder should be able to provide warranty claims within 3 weeks.
